#### FROM THE CO-CHAIR

#### Referendum

At our meeting on 17 October, held shortly after the Referendum results were announced, we respected the request from Indigenous leaders asking for a 'week of silence', curtailing our agenda accordingly. Some of the positive outcomes recalled included the Yes23 campaign galvanising over 100,000 volunteers nationally and organising over 230 campaign events, including some in the Macnamara electorate where the result was 63.8% Yes and 36.2% No, compared with Victoria -



44.9% Yes and 55.03% No; the country's smallest margin. We will wait for further guidance from our respected leaders, Elders and peak organisations then review our activities for 2024.

#### **Council News**

At the Council Meeting on 4 October, a motion was passed to support the Yes vote in the Referendum. It supported the Uluru Statement from the Heart and also supported clear and accurate information for the community to make an informed decision on their vote in the Referendum. PPCfR congratulates the Council, who also reaffirmed its commitment to develop a third Reconciliation Action Plan. Ned Valent, former Gathering Place Development Officer, Community Building and Inclusion, is now working with Stonnington Council; we wish him well.

#### **Film Night**

My thanks to Fiona Darroch for arranging an excellent social outing for members last month to watch *Our Voice Our Heart*, a fascinating documentary featuring two Indigenous men visiting communities up north to learn about the Indigenous Voice to Parliament. The event was hosted by Regen Projects & Regen Melbourne teams at their magnificent premises in The White House, 11 Princes Street, St Kilda.

#### **REFERENDUM AFTERMATH**

The outcome of the Referendum calling Australian voters to enshrine an Indigenous Voice in Parliament was that No led Yes 60% to 40%. Following a 'week of silence', prominent Yes campaigner Thomas Mayo said: "While the outcome was disappointing, in all my years of advocacy for Indigenous rights, I have never felt such levels of solidarity. We are nearly 40 per cent walking together. Almost seven million Australians voted 'Yes'. Both major parties would kill for a first preference vote like that. And we do need an independent voice".

A group of unnamed Aboriginal leaders ended their 'week of silence' with an open letter that slammed the 61 per cent of Australians who voted No as having committed a 'shameful act'. The Indigenous leaders have revealed they may push to establish a Voice anyway after 8.6 million Australians voted No. Their statement said that the truth is the majority of Australians have committed a shameful act, whether knowingly or not, and there is nothing positive to be interpreted from it. "We needed truth to be told to the Australian people. Rejection of constitutional recognition will not deter us from speaking up to governments, parliaments and to the Australian people. We will regather in due course and develop a plan for our future direction."

Dr Jill Gallagher AO, CEO of the Victorian Aboriginal Community Controlled Health Organisation, and other Aboriginal community leaders in the Yes23 campaign group reached out to the Macnamara team and other local campaign leaders on behalf of the many community leaders in the Yes campaign, noting the campaign has not been in vain and that there will be more to come. Jill asked that we share the video *65,000 Years Strong* produced by Clothing the Gaps and set to Jess Hitchcock's song *Unbreakable*.

#### **HISTORY IS CALLING FORUM**

A crowd of around 800 people filled St Kilda Town Hall on 5 October for this forum, organised by Yes23 and supported by Macnamara for Yes. Speakers were Josh Burns MP, N'Arweet Carolyn Briggs, whose Wominjeka/Welcome to Country included sobering accounts of her family's history, and keynote speaker Thomas Mayo, a signatory to the Uluru Statement from the Heart. He asked the audience to imagine if we were in his position and our backyard was taken away and never given back, we were removed from our culture, told it was worthless and not allowed to speak our language; how would we feel? He poignantly suggested people reflect on their attitudes when voting in the



Referendum and recited the Uluru Statement From the Heart. Singer/songwriter Paul Kelly's three songs included *Making Gravy* in honour of First Nations people incarcerated in jail.

Thomas Mayo delivered a personal, passionate speech at the History is Calling Forum.

#### **RECONCILIATION GROUPS** Reconciliation Victoria

In spite of the outcome of the Referendum, the path to Reconciliation will continue and RecVic will commence work immediately to develop their next 2024-2029 strategic plan. It will be built on strong partnerships with Aboriginal and Torres Strait Islander people and will set the vision for what First Peoples tell us Reconciliation and self-determination should look like in Victoria.

#### New Message Tree Alliance - Voice: Truth: Treaty

Formerly Get Out West, the group celebrated its launch last month with a smoking ceremony and Welcome to Country by Jaeden Williams, a proud Yalukit Willam man of the Kulin nation. The new name better reflects new priorities and highlights the significance of the Message Tree at the corner of Thompson St and Nelson Place, Williamstown. The tree was removed by the local Council in 1857. Following recommendations in the Message Tree report, Council has agreed to re-planting the tree in its original location. The project has led to further work uncovering what we call the hidden history of Hobsons Bay and surrounding areas and consulting with the Heritage Librarian at Williamstown Library. It worked well, with Mike and panel members answering his questions and helping inform the attendees. Unfortunately, as we know, the Yes vote was not successful. Elsewhere, Keith and I were invited by Debra Reys, philosophy teacher at Lloyd Street Primary School in East Malvern, to take part in the launch of some art panels in the school grounds. They were painted by Wurundjeri and Yorta Yorta artist Simone Thomson, and we were invited to cut a ribbon unveiling the panels in the school's playground. We also learned about the symbolism of each panel, explained by different students. Among the visitors attending was local MP Dr Michelle Ananda-Rajah. Keith and I have been invited to the school on many occasions to take part in events organised by Debra, who has Wiradjuri heritage. We've always been most impressed by these events and the way the school students are invited to participate and learn about many aspects of First Nations culture. Sadly,



it was the last event to be organised by Debra who has decided to retire; we wish her all the best in her retirement. *Ro Bailey, Secretary*
