FIRST PEOPLES' ASSEMBLY ELECTIONS

Wamba Wamba, Yorta Yorta, Dhudhuroa and Dja Dja Wurrung woman Ngarra Murray and Gunditjmara man Rueben Berg have been elected as Co-Chairs for the First Peoples' Assembly of Victoria at the first meeting of the Assembly's second term. The Assembly is the elected 'voice' for Aboriginal and Torres Strait Islander people in Victoria, and this term, its members will negotiate a statewide Treaty with the Victorian Government. Ms Murray, who was re-elected to the Assembly, is a community development and human rights expert and has led Oxfam Australia's First Peoples' programs for the last decade.

Mr Berg, also returning to the Assembly for its second term, is a trained architect and was previously a



Commissioner for the Victorian Environment Water Holder and a member of the Heritage Council of Victoria. For details of all the new members by region, visit https://www.first peoplesvic.org.

In other news, Assembly members Aunty Esme Bamblett and Uncle Rodney Carter will be leading the Elders' Voice, bringing Elders together across the state to yarn and share their knowledge. The Elders' Voice is a platform for Elders in Victoria to provide cultural authority and guidance to the work of the Assembly. The Youth Voice initiative will be led by Assembly members Alice Pepper and Jordan Edwards.

REFERENDUM NEWS

Prime Minister Anthony Albanese has announced that the date of the Voice to Parliament Referendum will be Saturday 14 October, marking the start of the formal campaign period of about six weeks. The launch is set to take place in Adelaide, between 30 August and 2 September, just days before two sitting weeks of parliament from 4 September and shortly before the PM departs Australia for international summits and meetings in Indonesia, the Philippines and India. SA was chosen as the state in which to launch the campaign because the Yes camp, according to reliable sources, believes the state will be decisive in determining whether the campaign wins the required majority of four out of six states voting in favour of the Referendum. The polls are still fluctuating on the support for the Yes and the No campaigns. However, in Victoria, and particularly locally within the City of Port Phillip, there is a lot of positive energy and campaigning happening, with volunteers from groups such as Macnamara for Yes being actively involved in door knocking, flyering, kitchen table discussions and talking to the wider community; see volunteers@yes23.com.au. Many local businesses, organisations, faith groups and sporting groups are supporting the Yes campaign, and the Australian Electoral Commission has produced an informative booklet, Recognising Aboriginal and Torres Strait Islander peoples through a Voice - Voice.gov.au.

LANGUAGE IN SCHOOLS

The Victorian Labor Government has announced Aboriginal language names will be used for all 14 new government schools due to open next year. From the Wadawurrung words 'Nganboo Borron', meaning 'children first, nurturing on your shoulder', to the Bunurong word 'Topirum', meaning 'star', new schools in Victoria are set to be named in various local Aboriginal languages. This is the first time the new school naming process consulted on a short-list of

Aboriginal language names, receiving more than 7000 submissions. The announcement of the school names follows a policy change in March to introduce the new requirements, including mandatory consultation with Traditional Owner groups and extending the use of the Engage Victoria platform for public consultation on new names. There will also be names for four new kindergartens. A full list of translations of the school names can be found on Schoolbuildings.vic.gov.au. (None are in the City of Port Phillip).

PORT MELBOURNE PRIMARY PROJECTS

On 30 July, students from Port Melbourne Primary School and volunteers from Port Melbourne Bunnings planted 250 native plants around the school's main oval. The project is being spearheaded by volunteers Anthony Moran and Melinda Williams, who run the primary school's gardening program. The day also consisted of installing new fencing panels across the front of the gardens to protect the newly planted plants from foot traffic during school recess. This is the first phase of a school-wide project to incorporate local native plants throughout the school grounds. Next steps will include labeling all of the plantings with their Indigenous names and uses.

RECONCILIATION VICTORIA NEWS

BAIL REFORM DELAYS

Aboriginal advocates along with legal and human rights advocates condemned reports that urgent bail reform in Victoria will be delayed by at least 12 months in a proposal by the state government, despite a coroner in January calling for the current laws to be scrapped and labelling them a 'complete unmitigated disaster.' The Bail Reform bill will be introduced into parliament after months of consultation, sparked by the coroner's report into the death of 37-year-old Gunditimara, Dja Dja Wurrung, Wiradjuri and Yorta Yorta woman Veronica Nelson while in custody. Victorian Aboriginal Legal Service chief executive and First Peoples' Assembly member Nerita Waight questioned why a potential delay was necessary. The proposed reforms would remove the controversial reverse-onus test for low-level offenders applying for bail. However, there is speculation the changes would not start for 12 months after they are legislated and won't completely remove the unacceptable risk test. Adults accused of bail-related offences will no longer fall under the provision, in-line with recommendations by the coroner, however all other offences captured by the test would remain. The Royal Commission into Aboriginal Deaths in Custody recommended that, along with an increase in access to bail, prison should only be used as a last resort. Currently, over 37 percent of people in detention in Victoria are not sentenced. For women, this figure sits at 40 percent.

STONNINGTON NEWS

Reconciliation Stonnington held its 25th AGM on Wednesday 9 August. Our guest speaker, Ian Hamm, gave a very personal and insightful talk, speaking passionately about the upcoming Referendum. His message on the Voice was simple and straightforward all that is being asked for is for First Nations peoples to be able to speak to government on matters that concern them. Member Councillor Mike Scott spoke in place of the Stonnington Mayor, Councillor Jami Clisaris, who was unable to attend at the last minute. Mike spoke about Stonnington's progress on RAP events and also on what our group, RecSton, has meant to him over the years; it was most rewarding to hear what Mike had to say. After the meeting, members and guests engaged in drinks and nibbles and further chats about the content of the talks. Since sending out Port Philip Citizens for

The centre, headquartered at Aarhus University, Denmark, is a global institute dedicated to changing news culture, rebuilding journalist integrity and encouraging the development of healthy democracies. Grant will steer the Centre's mission in the Asia Pacific region. Stan was formerly Vice Chancellor's Chair of Australian-Indigenous Belonging at Charles Sturt University.
